Dr. Taylor serves as the Chief Medical Officer of Clover Health's Value Based Care division. She is dedicated to educating and enabling physicians and healthcare organizations to provide higher quality but more affordable healthcare. In addition to practicing as an internist, her career has focused on helping her organizations to succeed in the transition from fee-for-service to value based care.

Dr. Taylor is driven by her commitment to physicians playing pivotal roles in major decisions that shape healthcare delivery in their communities and she collaborates with provider groups and healthcare systems nationwide to facilitate. Dr. Taylor started her practice as an internist at The Iowa Clinic in West Des Moines, Iowa. She served on their Board of Directors and then Chief Quality Officer. With a strong focus on preventative medicine, screenings, chronic disease management, and decreasing unnecessary utilization, there was marked improvement in patient outcomes and overall cost of care. During these years she served as Dept of Medicine Chair for Unity Point Des Moines and was Director of the Women's Health rotation for the Des Moines internal medicine residency.

She served as CMO at McFarland Clinic in Ames, Iowa, serving as medical director to the practicing providers and directing the value, population-health efforts organization wide.

She was also the medical director of the Stratum ACO in the Medicare Shared Savings Program, working with the Stratum organizations to design and implement initiatives to succeed in shared savings programs.

Dr. Taylor's dedication to physician involvement extends beyond her role at Clover Health. She is the current President of the Iowa Medical Society and is a strong advocate for physician, patient and community interests at both the state and federal levels. She serves on the Board of Directors of Wesley Life (senior living communities and older adult wellbeing mission) and also on the board of Above and Beyond Cancer. Additionally, Dr. Taylor serves on the state of Iowa HIE (CyncHealth) Board of Directors.

A respected member of the American Medical Group Association (AMGA), Dr. Taylor has held leadership positions including past Chair of the AMGA Foundation and the Quality Council.
